Summary of amendments in the MOA of the Company

S. No.	Changes
1	Existing Clause V of Memorandum of Association of the company has been substituted thereof by the following new Clause V as under:
	 "V. The Authorized Share Capital of the Company is Rs. 1,00,00,000/- (Rupees One Crore only) divided into 50,00,000 (Fifty Lakhs) equity shares of Rs. 2/- each with power to increase or reduce from time to time in accordance with the regulations of the Company and the legislative provisions for the time in force in this behalf. Upon any increase of the Authorized Share Capital, the company is to be at liberty to issue any new shares with any preferential, deferred, qualified or special rights privileges or conditions
